**SISTRY FOUNDATION** is a non-political, non-communal, non-profit making and non-Governmental organization, the main objective of which is to cause socio-economic empowerment of the poor and marginalized with a prime focus on the distressed and downtrodden Women and Children. **SISTRY FOUNDATION** actually started with the joint effects of some enthusiastic youth (boy & girls) by organizing game & sport and some cultural program since 2008. This was temporary programme & seasonal basis with the gradual Expansion of its games, sport and cultural wings this organization group feels to build a permanent youth club & for this purpose they came forward & convene a meeting for this purpose. All of them healthily accepted the noble proposal of the Founder Group.

The founder of this Trust then started organizing sports & cultural programmed throughout the year. As the area is very much backward and interior the people of this area are very ignorant and illiterate. Due to this, founder of the Trust organized several awareness camp and Adult literacy programme forwomen. For this purpose they also collected local contribution with high satisfaction. ## Activities at a Glance

## **Training & Capacity Building**

#### (i) Farmers Mobilization of PODF-ID Project under NABARD:

The concept of '**Farmer Producer Organizations**, (FPO)' consists of collectivization of **Producers** especially small and marginal **farmers** so as to form an effective alliance to collectively address many challenges of agriculture such as improved access to investment, technology, inputs and markets. So FPO will be converted to FPC for good and dynamic input & output business.

NABARD provides financial and technical support to the producer organization and NABARD has set up a Farmers' Technology Transfer Fund (FTTF) to be used to facilitate transfer of technologies and market linkages especially through Farmers' Clubs besides need based support for formation of Producers' Groups of farmers' Clubs etc. Ultimately FPO will be converted to FPC for good business including modern technology and necessary related action.

During the year under report **SISTRY FOUNDATION** has given training the farmers through FPO at Purba and Paschim Bardhaman district. 6350 farmers have been trained under PODF-ID Project during the 2021-2022 financial year.

#### (ii) Exposure visit under PODF:

Around 80% of the Purba and Paschim Bardhaman population depends on agriculture for their livelihoods. Around 40% of them are also involved in animal husbandry. The majority farming at a subsistence level is using traditional methods. However the context of agriculture in Bardhaman is changing with increasing challenges of reduced soil fertility, erratic weather patterns due to climate change and changing markets overall make a market oriented company. In order to counter these challenges, small farmers need to change the way they farm in terms of what they grow and how they grow it, but they have no skills, knowledge and capacity to improve their productivity within this context.

SISTRY FOUNDATION acknowledges the need to support and trained farmers so that they can

reach their potential capacity for farming, and thus implements a series of interconnected activities that address the challenges facing member capacity. So SISTRY Foundation has arranged seven exposure visits with no of 225 farmers of 12 FPCs including 170 men and 55 women in the year 2021-2022. Those Exposure Visits are following:

#### (iii) Farmers Awareness Camp:

SISTRY foundation has formed 12 FPCs in district of Purba Bardhaman as a POPI of NABARD. Those 12 FPCs as a company collect their share holders and share money from among the small and marginal farmers. It is necessary to arrange awareness camp regarding agriculture, horticulture, animal husbandry, etc. for improving their livelihood.

SISTRY foundation has arranged Farmers Awareness Camp with the No. of 4750 share holder farmers of the 12 FPCs including 2800 men and 1950 women at different area under different Block in the district of Purba Bardhaman in the year 2021-2022.

## **Awareness Programmes:**

## i)Kitchen Garden:

A **kitchen garden** is where herbs and vegetables are grown around the house for household use. Since early times a small plot near to the house has been used for growing a variety of vegetables according to the season. Local varieties such as radish, broad leaf mustard, chili, beans, pumpkins etc.

**Kitchen gardening** is something all of us can do to make our cities greener. It's a **garden where** you grow your own food— herbs, vegetables, fruits. What's more, it gives city dwellers a chance to produce their own food—fresher, healthier—and learn in the process about local varieties.

**SISTRY FOUNDATION** has been working to prevent the situation. The Trust arranged the awareness camps with the No. of 480 farmers including 280 men and 200 women at Purbasthali I & II and Kalna I Block Purba Bardhaman District in West Bengal.

## ii)Alternative Farming:

'Alternative Farming ' as it applies to the area of agriculture can be defined as 'A systematic approach to farming intended to reduce agricultural pollution, enhance sustainability, and improve efficiency and profitability.

The term 'Alternative agriculture ' as it applies to the area of agriculture can be defined 'A as systematic approach to farming intended to reduce agricultural pollution, enhance sustainability, and improve efficiency and profitability. Overall, alternative agriculture emphasizes management practices that take advantage of natural processes (such as nutrient cycles, nitrogen fixation, and pest-predator relationships), improve the match between cropping patterns and agronomic practices on the one hand and the productive potential and physical characteristics of the land on the other, and make selective use of commercial fertilizer and pesticides to ensure production efficiency and water, energy, and biological resources. Examples of alternative agricultural conservation of soil, practices include use of crop rotation, animal and green manures, soil and water conserving tillage systems, such as no-till planting methods, integrated pest management, and use of genetically improved crops and animals. Consonant with sustainable agriculture, alternative agriculture focuses on those farming practices that go beyond traditional or conventional agriculture, though it does not exclude conventional practices that are consistent with the overall system'

During the year 2021-2022 under report **SISTRY FOUNDATION** has arranged awareness camps on Alternative Farming with the No. of 420 farmers including 240 men and 180 women in Purba Bardhaman District in West Bengal.

## iii)Cattle Farming :

**Cattle farming** is **done** for two purposes: Dairy: for getting milk. Draught: animals are used for **agricultural** tasks like tilling, irrigation and carting. Mitch breeds (dairy animals): These include the animals which are kept for obtaining milk.

The cattle farm is considered to improve farmers' total **income** and to boost their living conditions. As a means of manure for soil enrichment and as a source of bio fuel, the animal waste which is produced can be used. For a significant number of people, it is a source of employment.

During the year 2021-2022 under report SISTRY FOUNDATION has arranged awareness camps for **Cattle Farming** with the No. of 325 farmers including 190 men and 135 women at Purbasthali I & II and Kalna I Block in Purba Bardhaman district in West Bengal.

This Detailed Project Report has been prepared for the handloom weavers of Kalna I & II blocks, Purbasthali I & II blocks and Katwa I & II blocks of Purba Bardhaman district of west Bengal for implementation of soft interventions, hard interventions and thematic interventions to facilitate more than 500 handloom weavers and spinners in the cluster. An Off-Firm Producer Organization (OFPO) with the handloom weavers and spinners participation will be formed which will act as facilitating organization towards overall development of the cluster.
